

Illinois Heat Tournament Setup

No Coolers or outside food/beverages may be brought into Illinois Heat Volleyball Center.

Violators will be fined \$25 per offense.

Playoffs are 2 out of 3 games.

Game 1 & 2 to 25, Game 3 to 15, NO CAP.

All match times are approximate except 1st match of day.

Match warm-ups will start as soon as the prior match is done.

Playoffs will start as soon as pool play is finished and in some cases before pool play is finished.

Tie-breaking procedures will follow the Region rules:

To determine which teams advance to play-offs/seeding for playoffs, please use the following criteria:

0) MATCHES WON/LOST RECORD - Used for Best of 3 format only

1) GAMES WON/LOST RECORD

2) HEAD TO HEAD COMPETITION

3) TOTAL POINTS FOR/AGAINST

Reminder: New USAV Rule this year - NO ball handling off the court.

All reffing teams must supply a R1, R2, (2) Linespeople, Scorekeeper, and Libero Tracker.

A coach/director MUST be the R1...NO EXCEPTIONS!!!!!!

No cell phones, iPods, or any other electronics may be used by any of the reffing team.

Please make sure you have someone who knows how to keep the scorebook when your team is reffing.

Warm-ups will be 2-4-4 all day.

Note for Out of Region Teams - The Great Lakes Region does NOT allow the Libero to serve.

The Tournament Director can change the playoff format if significant delays arise.

Some Bleacher seating is available, but you are welcome to bring your own chair for in the gym.

Admission is \$3 for Adults, \$1 for students and seniors, children under 5 are free

Full concession stand and t-shirt shop available.
